- **Scholarship**

Demographer/geographer with seven years' service as a full professor and associate professor. Taught economic geography, empirical research methods, cartography, and geographic information systems.

Author of 72 peer-reviewed articles, 2 books, and more than 100 conference papers and reports. Regular contributor of applied, collaborative research on subjects of direct importance to library practice. My papers have been cited more than 3,400 times and have appeared on the reading lists of several dozen courses.

Special expertise in scholarly communication and library collection development.

Recent research has focused on citation metrics and expert assessments of journal quality; free online textbooks; the effectiveness of unconventional access mechanisms such as Academia.edu, ResearchGate, Anna's Archive, and Sci-Hub; data journals; DEI assessment of library collections; market structure and pricing of conventional and Open Access journals; journal selection and acquisition; information literacy assessment; errors in the bibliographic citations generated by ChatGPT; and the effectiveness of software designed to detect AI-generated writing.

Strong advocate for information products and processes that can enhance the extent, breadth, and impact of faculty, student, and alumni research. Discerning, even-handed approach to the evaluation of innovative business models and technologies.

▪ **Strategic planning and institutional change**

Experienced in strategic planning and educational assessment, both within the library and university-wide.

Completed a 10-year library strategic plan with input from library personnel, campus stakeholders, and external advisors.

Chair of university-wide strategic planning and accreditation committees. At Menlo College, helped transform a multipurpose institution into an entrepreneurial business school. Garnered faculty support for major changes in academic programs.

Doubled funding for professional development. Increased opportunities for personnel with proven abilities but unconventional backgrounds.

▪ **Resource planning and management**

Devoted to mission-centered, evidence-based decisionmaking and resource allocation. Experienced in large-scale resource allocation, fundraising, management of complex budgets and restricted endowments, and space planning and renovation.

Responsible for library budgets of up to \$5 million. Managed two dozen restricted endowments, each with unique spending, tracking, and reporting requirements. Adept at dealing with changing priorities and mid-year budget cuts.

Designed and implemented a comprehensive, zero-based journal selection program that dramatically increased our holdings of the journals most important to faculty (*wanted journals*) without increasing expenditures. This program, based on the principles set forth in my published work, led to a 50% increase in the percentage of wanted journals held, a 35% reduction in cost per wanted journal, and a substantial reduction in inequality of holdings across academic departments.

Led several renovation projects that have provided for the more flexible use of space. With I.T. and other campus agencies, planned and built a Learning Commons within the library. Coordinated a major electrical/HVAC upgrade and the large-scale conversion of stacks space to study space.

▪ Learning environments and student services

Dedicated to high-quality student services. Instituted student-centered, “no hassle” training of library staff. Established 24/7 library hours during the academic year. Helped maximize student satisfaction and retention by maintaining on-site library services throughout the COVID pandemic, even when classes were held remotely.

Strengthened the library’s status as an educational and co-curricular hub by removing physical, technological, and socioeconomic barriers to library collections and services. Eliminated printing charges and restrictions.

Upgraded collaborative spaces and converted stacks space to study space. Brought allied services, such as tutoring and I.T., into the library building.

Strong supporter of Manhattan University’s Camino degree program for native speakers of Spanish. Increased support for Camino even when faced with serious staff and budget shortfalls. Expanded instructional programs for student groups such as the National Society of Black Engineers.
